TERMS AND CONDITIONS:

- 1) I agree to pay the full tuition balance in full by May 31st 2010.
- 2) A 10% non-refundable deposit is required at registration.
- 3) BIS-NY Summer Camp has permission for my child to participate in all camp programs, including field trips that are planned and supervised by BIS-NY Summer Camp.
- 4) BIS-NY Summer Camp has the unrestricted right to terminate this enrollment agreement at its sole discretion. In the event of such termination due to camper behavior, BIS-NY is not obligated to refund any tuition or any unused amount of the tuition.
- 5) CANCELLATION POLICY: If cancelling prior to May 31st 2010 tuition is fully refundable. After May 31st 2010 tuition is non-refundable.
- 6) BIS-NY Summer Camp has permission to reproduce and publish any photograph, video or likeness of my child for advertising, commercial or any lawful purpose.
- 7) BIS-NY Summer Camp has permission to treat my child for routine, minor injuries such as scrapes and bruises. In the event that a parent, emergency contact or the family physician cannot be contacted in an emergency, BIS-NY Summer Camp has the permission to have my child examined at a hospital emergency room.

WAIVER AND RELEASE:
